The Purchaser agrees that the kitten/cat will be spayed/neutered by the time the kitten/cat reaches seven months of age at the Purchaser's expense. Within seven months of age, of said kitten/cat, Purchaser will provide the Seller with documentation of the spay/neuter by providing the Seller with proof of sterilization in the form of a veterinary bill on letterhead of the veterinarian's office complete with the veterinarian's name (may be printed) and business name (must be typed) including the address and phone number of the veterinarian office from the veterinarian that performed the spay/neuter. Purchaser agrees that the Seller may contact said veterinarian to confirm the sterilization (please notify said veterinarian of this agreement). If the kitten/cat is not spayed/neutered by seven months of age and proof of sterilization is not provided by seven months of age, Seller will enforce breach of contract. If said kitten/cat is six months or older at the time of purchase, the Seller will have the kitten/cat spayed/neutered before the kitten/cat is transferred to the Purchaser.
